## What's next...

Next year 2017 marks the start of the fourth year of operation for the ISC. It has been a huge first three years, and I have been privileged to lead this work. But there is still much more to do.

We have some projects still ongoing from 2016. These include developing guidance on how to achieve competency and how to consistently implement lead metrics. This metrics work will support the ISC members' lead metric benchmarking which will commence in 2017. We will also be finalising the suggested learning outcomes for engineering students, following the consultation period. The next step will then be to look at how to help universities take these on board. We will be looking to further promote the process safety chapters of the OHS Body of Knowledge work with the Safety Institute of Australia, and continue to focus on safety holistically. There is also another ISC Case Study on the way, so stay tuned for the release of the next one.

There are also plans to continue to grow the staff and develop more activities around the world. We are planning to recruit a technical role in the UK region to develop and grow the membership there.
