It was also great to see Citi Bank referencing the ISC lead metrics guidance in their annual report on process safety among companies listed on the Australian Stock Exchange. The message on process safety and a focus on assurance is definitely reaching a range of organisations and industry sectors. What's next...

We are almost finished preparing for the ISC Process Safety Masterclass that we will be delivering at Chemeca in Adelaide later this month. This will be a chance for the ISC members to communicate with academics involved I teaching chemical engineering what industry expectations are for process safety knowledge. It is also a time where we can assist academia with resources and information to assist the teaching of process safety. This project is a very long term one, but is an important one for the future of industry.

We are also doing the final editing of the OHS Body of Knowledge chapters on Process Safety Management and Process Safety Hazards (Chemical). This is an important resource that is used to inform the competence of OHS Professionals. It is important that both OHS and Process Safety Professionals work together to improve safety outcomes, as it is too easy for competing demands to result in unintended consequences for one or both of these areas.

Work is also continuing on guidance on how to build competency as well as tool kits for implementing lead metrics. We are also exploring how we can commence benchmarking of lead metrics into 2017. So stay tuned for information on this.
