What we have been up to...

The ISC launched the supplementary guide – how to build and develop profess safety competence. It provides an example of the tasks and activities that could be undertaken to achieve the relevant level of competence in the range of competence topics defined in the 2nd edition of the Competency guidance document in April. The sample University Laboratory Process Safety management system will be available in July. This document has been developed to assist academic institutions in their application of process safety management in their laboratory activities. Both of these when available can be downloaded from the ISC website at www.ichemesafetycentre.org

In late March the first senior leaders breakfast briefing was held in Houston. The discussion centred around culture and governance in process safety relating to some lessons from the banking sector. A small turnout but feedback was very positive.

As well as exhibiting, we attended the 15th Global Congress on Process Safety in New Orleans in early April. I presented a paper on "Taming the river rapids – how process safety can apply outside the processing industries". We launched our seventh and eights case studies "Chemical Plant" which focuses on inherently safer design and "Underground Pipeline" which focuses on risk management.

I presented a webinar on Due Diligence in Process Safety as part of the Chemical Processing Process Safety Series on 11 April. John Bresland, former US Chemical Safety Board Chair, ran a webinar on Operator Competency on 17 April. This is <u>available</u> on the website. We will do a further 2 webinars with Chemical Processing and develop some podcasts with them as well.

We ran 3 Process Safety Leadership and Culture programmes, 2 in-company and the public programme in London which had 9 participants. This take the total number of programmes run this year to 7.

In May at Hazards29 Zsuzsanna and I ran 3 workshops; two covering the case studies "Chemical Plant" and "Lift Off". Zsuzsanna also ran a workshop on creeping changes which was well received by the audience.

Margaret Donnan, the independent Chair of the ISC Advisory Board was reappointed to another 3 year term from August 2019.

The ISC held two networking events in the past quarter, one in New Orleans, USA and one in Birmingham, UK.

These events were used to engage with members and potential members and were well attended.
