What we have been up to...

We have not been able to attend any face to face conferences or events that were due to take place during the last quarter of the year. However, the IChemE Safety Centre have been extremely busy. We continued to run webinars on a regular basis. All the webinars can be viewed on the ISC's YouTube Channel or the ISC website.

The ISC have taken part in two virtual conference and exhibitions. The first being Mary Kay O'Connor Process Safety Center Symposium where I ran a case study and presented on "Process safety implications in a changing environment. The second virtual conference and exhibition was IChemE's Hazards. All the presentations were pre-recorded but broadcast as part of a live timetable with live Q&As. Zsuzsanna presented on "Creeping Changes" and I presented on "How stressed is your facility".

Zsuzsanna was involved with the kick-off meeting of the European Safety, Reliability & Data Association (ESReDA) new Project Group on "Risks, Knowledge and Management" which was held on 19th November. The project will focus on relationships between "risks", "knowledge" and "management". The scope defined below will be of interest to system designers, system operators, managers, maintenance, lawyers, insurers, and regulators, and many others working on safety and security including natural hazard management.
